

Resolution 25-05

Authority Member Jensen moved approval of the following resolution:

A RESOLUTION HONORING JANEL ROGERS OF THE COLORADO SPRINGS POLICE DEPARTMENT AS TELECOMMUNICATOR OF THE SECOND QUARTER 2025.

**WHEREAS**, the El Paso – Teller County Emergency Telephone Service Authority was created to provide a two-county-wide 9-1-1 system; and

**WHEREAS**, the members of the Authority wish to recognize outstanding call takers and dispatchers within the system through the Telecommunicator of the Quarter and Telecommunicator of the Year programs; and

**WHEREAS**, On the evening of May 15, 2025, Emergency Response Technician Janel Rogers answered a 911 call with an open line with a male and female screaming in the background. Finally, a distraught mother yelled into the phone that her 7-month-old baby had drowned in the bathtub. ERT Rogers took control of the call and confirmed the location, and that the child was not breathing. The mother noted that blood was coming out of the baby's lungs.

**WHEREAS**, ERT Rogers continued to calm the mother by providing reassuring statements and gathering critical life status information for responders. ERT Rogers quickly guided the mother and kept her focused on providing lifesaving CPR for her baby. She reassured the mother that help was on the way while CPR was being administered. ERT Rogers provided instructions for ten cycles of respiratory CPR for the baby. She paused during the instructions to confirm the noise she was hearing was air going into the baby's lungs. ERT Rogers used a firm caring tone during the entire call that enabled the mother to focus on the care of the baby.

**WHEREAS,** Making sure that the mother continued CPR, ERT Rogers gave instructions for someone else to open the front door for responders. Medical Lt. Buttenweiser contacted communications and noted that ERT Rogers did a great job, that brain activity was noted, and everything was moving in the right direction. ERT Rogers did an excellent job in a challenging situation.


**NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:**

Authority Member Koch seconded the adoption of the foregoing resolution. The roll having been called; the vote was as follows:


